These objectives offer a clear framework for understanding the intended purposes behind Shariah rulings and their broader implications.

The CIBAFI Professional Programme on Maqasid al-Shariah is tailored for practitioners within the Islamic finance industry. It aims to deepen participants' understanding of Maqasid al-Shariah, their application within Islamic finance and banking, and the methodologies employed in this context. The programme further explores how CIBAFI's Principles of Sustainability are aligned with Maqasid al-Shariah, creating a coherent connection between Shariah objectives and sustainability principles.

## Programme Objectives

The primary objective of the CIBAFI capacity-building training on Maqasid al-Shariah is to broaden participants' knowledge and understanding of Maqasid al-Shariah and their practical application to Islamic finance.

Key learning outcomes include:

- Gaining an in-depth understanding of Maqasid al-Shariah and dispelling common misconceptions.
- Outlining the methods and ways of determining Maqasid al-Shariah.
- Discussing the classifications and main determinants of Maqasid al-Shariah.
- Examining the relationship between Maslahah (public interest) and Maqasid.
- Addressing contemporary jurisprudential issues through the lens of Maqasid al-Shariah.
- Connecting the principles of Maqasid al-Shariah to the practices of Islamic finance.
- Establishing the link between Maqasid al-Shariah and sustainability within Islamic finance.
